Terms and Conditions for Tour Package

PAYMENT: A deposit of \$TBD per person is required at time of reservation to secure a confirmed booking. Final payment is due 70 days prior to departure. All reservation made within 70 days of departure require full payment immediately. Payments not received by the scheduled deadline dates per your tour agreement are subject to **penalties, late fees and or cancellation.** All payments should be made payable to CHAMPION SERVICES TRAVEL, PO Box 44140, Ft. Wash. MD. 20744. Credit card payments are not accepted for this booking. There is a \$39.00 charge for all return checks (NSF)

CANCELLATION & REFUNDS: A full refund of your deposit and other payments shall be refunded if CHAMPION SERVICES TRAVEL (CST) cancels the trip. Your deposit is nonrefundable if the individual participant or your group leader cancels within 70 days or less of the departure date. If canceled before 70 days of departure, all payments other than the initial \$TBD pp deposit plus any charges accessed by the travel suppliers will be refunded. All requests for refunds or cancellations must be made in writing and addressed to CHAMPION SERVICES TRAVEL before 70 days of the departure date. No refunds will be made for cancellations 70 days or less before departure, including the day of departure or no-shows (**No Exceptions**). In the case of such changes CST shall not be held responsible for such changes and no refunds or adjustments will be made to the tour price. The Tour Price includes only those items specifically stated in the published itinerary. Items not included in the tour price are: Passport and Visa fees, tips, gratuities, services charges, optional tour services, trip insurance, Hotel incidentals, certain countries airport departure fees, and thing of personal nature.

CST LUGGAGE TERMS: Although some airline carriers may allow up to two (2) checked pieces of luggage, we cannot. As a Group Only Travel Agency, our policy will only allow each passenger ONE (1) checked piece of luggage at the airlines said weight restrictions (44-50lbs). Notifications will be issued accordingly and per the tour booking weight restrictions.
